Our current provider, ZitoMedia, has been a nothing but difficult relationship and lacking services from the beginning for us. The church I served increased our service contract to Gigabit service with the assurance from ZitoMedia that they could provide this and that would increase our speed and capacity to carry our

weekly and other regular livestream video uploads. We were told that if we paid for the Gigabit service that our upload speeds would proportionally increase with our Gigabit download, so that our livestream video uploads would be assured. The evidence in the Speedtest documentation (see fast speedtest 1) 2 3 4 - 03042022.pdf we've uploaded shows that we are nowhere near the Gigabit service for which we pay and this has been a common experience for us for over a year since we increased the service and costs. Although there is a local office in Liberal, no local service numbers are available and the toll free access numbers leave us put on hold, at least a half dozen times over the past year and half, for several hours. Then, when you reach a person in a network call center in Pennsylvania and explain that your service is down (already for a week and sometimes two), they say they will put a ticket in. A few days later, a tech (one of two for the whole region contracted to do the work) will call or just show up; these guys are hard workers, but they are obviously inundated by service calls and not happy with the company they've contracted with due to poor equipment quality and a frequent breaks in the "Fiber loop around Liberal" and connecting cabling to homes and businesses. I've had important zoom call meetings, both in my workplace and in my residence, totally shut-down that had been planned months in advance due to ZitoMedia's service. I've heard the same experience from other leaders in our community.

My wife and I learned about EpicTouch, first through word of mouth and later through county and city elected and organizational leaders, regarding the excellent service in several towns close by and that EpicTouch was leading an effort to install Fiber-optic in Liberal - which for years has had a glut of potential internet and phone service providers, but a dearth of providers who were able to put the funds into infrastructure such as Fiber -- too much competition that kept a small-city hub in the Southwestern corner of Kansas without the internet services that were needed for modern businesses and residents.

EpicTouch first phase began with the far north quadrant of the city, where many wealthier families and the Seward County College and new large businesses and our SW Medical Center are located. Based on the evidence presented by now current customers, I believe that EpicTouch can provide the internet infrastructure with Fiber-Optic lines through the proposed Phase 2 and other projected phases until the entire city of residents and businesses are connected. This makes residents of Seward County and Liberal proud, because EpicTouch is "local" and, in general, people like to keep business local in Liberal, but most importantly they have proven to provide excellent service with relatively short response times while treating people like neighbors.

Seward and Stephens Counties have a long history of familial and agricultural and energy related business relationship. Our city and county leaders continue to provide incentives to future industry to increase and support an already large packing plant industry with accompanying growth and grooming farms. One common complaint about potential new businesses and industry corporations, who are considering a move to Liberal, is the lack of quality and high-speed internet in Liberal. Many small towns surrounding Liberal have enjoyed and made good use of Fiber-optic for months and years (in some cases) and the has contributed to stagnating the growth and business industry of our city. As a result, our population continues to decline and suffer. I believe, the state's support of EpicTouch would have a huge impact on keeping western Kansas strong with economic viability for many years to come. I hope the state will say 'YES' to the proposed Fiber expansion throughout Liberal. Thank you for your work.

It frequently drops off or it's so slow it is hard to get my work completed which is extremely frustrating when I'm on a deadline. I actually run three non-profits and one of my offices is located in an area that is serviced by Epic Touch. The difference in service is extremely noticeable. I never have a problem with Epic Touch. It is both fast and reliable.

I have United Wireless at home which drops off all the time and usually can sustain streaming a whole show. When I'm on a Zoom call, most of the time I have to keep the video off or the screen will freeze up.

At another office, I have AT&T which is not only slow but seems to just quit every day at 3 to 4 p.m. I've talked to the office but they haven't given me any solution to the problem.

I would like to see Epic Touch available not only in proposed expansion but throughout the whole community. I've never had a problem with Epic Touch but my friends have said that when they have had concerns, it was addressed quickly and effectively.

In rural Kansas, reliable and high-speed internet is critical for us in both education and work. I would really like to see Epic expanded to the community college and the surrounding area because the internet has been an ongoing issue for the college.

I hope the state will award this grant to Epic Touch so that a larger number of our residents will have access to an effective internet.
